
How to Install the App on Your Android Device . Please follow these step-by-step instructions to complete the installation.


- Step 1: Download the App from WhatsApp/Provided link and Open it. You might see a notification indicating the file type. If any warnings appear, you can safely ignore them and tap "OK" to proceed. If prompted to allow your phone to scan the file, select Scan. If permission requests are shown, follow the on-screen instructions to grant the necessary permissions.
- Step 2: Enable Installation from Unknown Sources. Since the app is not available on the Google Play Store, you must enable installations from unknown sources. Follow these internationally recommended guidelines: Access Device Settings: After downloading the APK, you may receive a notification that the installation is blocked due to security settings.
- Enable Unknown Sources: Open the Settings app on your Android device. Navigate to Security. (On some devices, you might need to go to Apps & Notifications > Special App Access > Install Unknown Apps.)Locate your messaging app (e.g., WhatsApp) and enable Allow from this source. Note for Android 8.0 (Oreo) and later: Installation permissions are managed on a per-app basis, so ensure that the permission is enabled specifically for the app you're using to install the APK.
- Install the APK: Once the setting is enabled, tap the downloaded Digital POE Screening.apk file in your notifications or file manager to start the installation. Follow the on-screen instructions to complete the process.



- Step 3: Install the App Locate the APK File: Go to your Downloads folder using a file manager or tap the notification when the download completes. Start Installation: Tap on the APK file. You may be asked to confirm if you really want to install the app; just click Install. Wait for the Installation: The app will install in a few seconds.
- Step 4: Open the App Once the installation is complete, you can click Open to start using the app. The app icon will also be added to your home screen or app drawer for easy access later.








Primary Screening Dashboard



LANDING PAGE AFTER LOGIN IS THE PRIMARY SCREENING DASHBOARD


- This shows primary screening analytics for head count and gender
- It allow filtering of the analytics by date, month and year




PRIMARY SCREENING

Screening for people who do not present any concerning symptoms or signs or have not reported any health complaints. It records gender and head count

PRIMARY SCREENING FORM





- If a traveler does not have any of the following: fever (38°C or higher), feeling unwell, continuous cough, difficulty breathing, diarrhea, vomiting, skin rash, chills, unusual bruising or bleeding, limb weakness, dizziness, or jaundice?, The screener continues to record gender and complete the primary screening
- For primary screening to conclude successfully, The greed complete screening button at the end of the form has to be clicked





HOW TO TRIGGER SECONDARY SCREENING


- Once a traveler has any of the indicated signs or symptoms
- Symptoms button is turned on and a form appears, Enter the traveler name who is being referred to secondary screening and click proceed
- Finally click the refer to secondary screening button and a notification for a traveler pending secondary screening will be created. This traveler is then moved to the holding area to continue with secondary screening


SECONDARY **SCREENING FORM**

- 1. Now fill in the whole form by clicking start screening (Symptom assessment, Traveler information step 1-6)
- 2. Countries should be selected from the drop-downs NOT manually typed for fields that require countries

- Upon completion of the form
- Case classification and recommended course of action is presented to the screener
- All cases that require referrals should have their referral data recorded first by clicking refer to nearest health facility before completing screening
- App case recommendation and course of action should be read and understood by the screener
- Click complete screening to create a national alert and record case


POE MANAGEMENT

USER MANAGEMENT


- Create, Update and Delete users/screeners/admins
